## Evaluation Components:

- Background and social history
- Medical and Dental assessment
- Psychological assessment
  - Behavioral and Emotional Screening System (BESS)
  - Brief Symptom Inventory (BSI)
  - Quick Neurological Screening Test-3 (QNST-3)
  - Wechsler Abbreviated Scale of Intelligence-2<sup>nd</sup> Ed. (WASI-II)
  - Stress Inventory for Parents of Adolescents (SIPA)
- Sex offender assessment (upon request)
  - Risk-Sophistication-Treatment Inventory (RSTI)
  - Multiphasic Sex Inventory Second Ed. (MSI-II)
- Substance abuse assessment
  - Adolescent Alcohol and Drug Involvement Scale (AADIS)
  - Children of Alcoholics Screening Test (CAST)
- Psychiatric evaluation
- Behavioral summary for the evaluation period. The juvenile will also attend school, group, recreation
- A final summary of recommendations regarding further treatment and placement

## Evaluation Rates

- Member & Affiliate Counties= Detention Rate + \$40 (max 30-days)
- Non-Contract Counties= \$120/day (free transportation)



## The following components can be offered separately.

- Psychological assessment- \$500
  - IQ included (\$300 separately)
  - Psychosexual- \$300 more
- Substance Abuse Evaluation- \$95
- Academic assessment (Psychoeducational) through our psychologist and in collaboration with AEA 267 and client's home school- \$300
- Psychiatric- \$600
